- 5. Capt Adams thanked Capt Shewchuk for his time and efforts as resident of the council in the last year.
- 6. Canada 150 Dinner Wrap Up Deferred to next meeting for comments from Capt Shewchuk. Capt Hollis reported on financial status about \$1000 surplus.
- 7. Depart with Dignity Sub-committee Capt Shewchuk not available. Deferred to next meeting.
- 8. Scholarship Sub-committee Capt Welsh not available. Deferred to next meeting.

NEW BUSINESS

- 9. Council Structure & Meeting Expectations: Important to attend. If not able, let someone know, and give proxy to another council member.
 - a. Proposed to have meeting once per month, to touch base, and keep momentum going forward. Meetings decided to be in first week of the month to give consistency.
 - b. All members of council encouraged to be members of Sub-committee. Maj Hildebrandt and Capt McRobert volunteered for Scholarship Sub-committee.
- 10. Open Councilor Positions: Capt Adams appointed Capt F. Milne to council as North/Kootenay Regional Councillor. Capt McRobert volunteered to assist Capt Milne.

11. Association Goals:

- b. One social event in each region (can be combined with PD). Suggested to hold events with family members to increase community connections and diversify network.
- c. CTC a valuable resource to use. Motion by Capt Adams to approve budget of \$150 per CTC for outreach events this summer, seconded by Lt(N) Clausen. 14 IN FAVOUR, 0 OPPOSED, CARRIED UNANIMOUSLY.
- d. Advanced survival skills PD session FTX for Association members to learn best practices and enhanced field leadership skills. Capt Daniels and Maj Hildebrandt to review and follow up if possible to bring to other regions.
- e. PD sessions in the northern and interior regions similar to what has been offered in the Lower Mainland/Fraser Valley/Island regions.

12. Regional Councilor Events and Outreach:

a. Aim to have PD and Social events in each of the regional areas by April 2018.

- b. Adventure Race similar to what is done for cadets, have CIC Association members events in each region.
- c. Regional councilors to have dates/place ideas completed by end of September.
- 13. Update on Association's Balance Sheets: In good health. Information posted to website.
- 14. Communications:

 - b. Minutes are posted to CIC BA page.
 - c. Lt Nobakht thanked and asked to continue work on site. Lt Nobakht unavailable to confirm as left meeting early due to previous commitments.
